## The Bremerton Symphony Association Participant COVID-19 Safety Acknowledgment, Liability Waiver and Release of Claims

As a participant in any Bremerton Symphony Association rehearsal, performance or activity (hereafter collectively referred to as "activity" or "activities"), you must be aware of COVID-19 precautions, and you must acknowledge potential health risks and waive any, and all liability associated with participation in activities.

While rehearsing in Manette Community Church or any other location, until notified otherwise, wind players when not playing, must wear a mask. String and percussion players must wear masks at all times.

<u>Individuals who fall within any of the categories below should not engage in</u>
<u>Bremerton Symphony Association activities</u>. By participating in a Bremerton Symphony Association activity, you certify that you do not fall into any of these categories:

Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with COVID-19, which include fever, cough, shortness of breath, and other widely publicized symptoms.

Unvaccinated individuals who have traveled internationally at any point in the past fourteen (14) days.

Unvaccinated individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

## **DUTY TO SELF-MONITOR:**

Members and volunteers agree to self-monitor for signs and symptoms of COVID-19 and to contact the Personnel Manager of The Bremerton WestSound Symphony at <a href="mailto:gdahl@bremertonsymphony.org">gdahl@bremertonsymphony.org</a> if they experience symptoms of COVID-19 within 14 days after participating with The Bremerton Symphony Association. The Bremerton Symphony Association has put in place preventative measures to reduce the spread of COVID-19. However, the Bremerton Symphony Association cannot guarantee that its members and volunteers or others in attendance will not become infected with COVID-19.

## **LIABILITY WAIVER AND RELEASE OF CLAIMS:**

I acknowledge that I derive personal satisfaction and a benefit by virtue of my participation with the Bremerton Symphony Association and I willingly engage in Bremerton Symphony Association activities.

ASSUMPTION OF THE RISK. I acknowledge and understand:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist;
- 2. I knowingly and freely assume all such risks related to illness and infectious diseases, such as COVID-19, even if arising from the negligence or fault of the Released Parties.

## RELEASE AND WAIVER.

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST THE Bremerton Symphony Association, ITS AFFILIATED PARTNERS (INCLUDING THE MANETTE COMMUNITY CHURCH, MARVIN WILLIAMS CENTER, ADMIRAL THEATRE, ST.
